SHOPLIFTING AND OVERSPENDING Where to go when you are looking for help

Updated: May 2024

Problematic overspending involves an uncontrollable urge to purchase things, often resulting in financial distress and emotional turmoil. It is not about poor financial management but is often linked to emotional issues such as anxiety, depression and low self-esteem. People may use shopping to cope with negative emotions or to feel a temporary sense of control or happiness. Similarly, shoplifting may be characterized by an urge to steal things, but not out of need or financial gain.

These behaviours can cause significant distress, legal trouble and damaged relationships. Help includes therapy, financial counselling, legal services and education.
