# HEIA Health Equity Impact Assessment

The Health Equity Impact Assessment (HEIA) tool, developed by the Ontario Ministry of Health and Long-Term Care (MOHLTC), helps to reduce disparities between population groups.

WHAT?	?	HEIA is a decision support tool used to identify and address potential unintended health impacts (positive or negative) of a policy, program, or initiative on vulnerable or marginalized populations.
WHY?		Addressing unintended impacts on vulnerable or marginalized groups can improve health equity and reduce avoidable differences in health between population groups.
WHO?	(2)	HEIA can be used by any organization within and outside the health care system whose work may impact health outcomes.
WHEN?	$\bigcirc$	HEIA is best conducted as early as possible, but can be introduced at any point in the development and planning process.
HOW?	( C) C)	A HEIA template, a workbook with step-by-step instructions and three supplements are available to guide users through the five step HEIA process.

### The five steps of HEIA

#### 1: SCOPING

Identify vulnerable or marginalized populations affected by a policy, program, or initiative.

#### 2: POTENTIAL 3: MITIGATION IMPACTS

Use available evidence to assess the unintended impacts of the policy, program, or initiative on the health of these populations.

Determine strategies to maximize positive impacts and minimize or eliminate negative impacts on these populations.

#### 4: MONITORING

Identify ways to monitor the implementation and effectiveness of the mitigation strategies. **5: DISSEMINATION** 

Establish ways to share results and recommendations to address equity.
